Windsong Ranch Goal and Mission:

To establish the participant in a functional, goal-oriented, moral lifestyle, free of addictions and any previously acquired debts.

Housing Agreement for Men

- *Resident is expected to arise and make bed and clean room and be prepared for the day's activities no later than 8:30 a.m. (earlier times may be requested with prior notice).*
- *Resident is expected to attend Bible study and prayer each morning at 8:30 (earlier times may be requested with prior notice).*
- *Resident is expected to attend all church services and other functions that may arise on occasion*
- *No food should be stored or consumed in bedroom.*
- *Resident is expected to do his own laundry at least once during the week*
- *Resident must wear appropriate clothing for all church services that are attended. (slack's, dress shirt, tie, dress shoes).*
- *No jewelry is permitted. (rings, necklaces, watches. etc)*
- *Resident is to participate in any work that is being done to enhance the program or around the farm.*
- *No secular music will be tolerated and television is prohibited.*
- *No personal radios or CD players are permitted. No portable radio or CD players.*
- *Phone use is limited to legal matters and emergencies the first 30 days, after the first 30 days you are allowed one phone call a week for 5 minutes.*
- *No incoming mail until after first 30 days*
- *No profanity, slang, or derogatory language will be permitted.*
- *No smoking or tobacco products will be allowed on or off of the premises while enrolled in program. No drugs or drug paraphernalia on the person or property No alcohol products may be used on or off the premises.*
- *Residents must wear modest apparel; tight fitting clothes or baggy clothes will not be tolerated, Residents must wear shirts tucked in pants at all times, No shorts may be worn and sleeve length must be below elbow*
- *Hair must be kept short and no facial hair is allowed.*
- *No courting will be allowed without prior consent.*
- *Male and Female clients are not to have any communication without approval from director*
- *Resident must provide his own toiletry.*
- *Resident will not be permitted to leave the premises without a counselor and written approval from director.*

- Resident must make appropriate counselor aware of their whereabouts at all times through out the day.
- Resident will not be allowed to retain money in his possession during the program. (Money earned will go toward housing and fines). Any remaining money will be saved, and given to participant when he exits the program.
- Resident will not be allowed to keep keys to any vehicle while enrolled in the program.
- There will be periodic search and seizure for contraband, Immediate Dismissal if found!
- **Clients are not allowed to have vehicle on premises while in program. NO EXCEPTIONS!**
- There will random drug testing and tobacco testing on all residents in program. (cost \$35.00 dollars)
- **A non-refundable fee of \$100 dollars will be charged for first court appearance due on court date.**

A non-refundable fee of \$550 dollars is required for the first month, and \$500 every additional month will be charged for each resident in order to cover the cost of housing. A transportation fee of \$30.00 (up to 100 mile radius, \$10 will be added for each additional 50 miles) will be charged for each trip to court, probation meeting, etc. Residents also will not be allowed to accept any gifts from outside people unless approved by authorized personnel.

The housing and meal cost for the first 30 days will be due when participant enters program and each successive 30 day period thereafter until departure from the program.

The housing cost for _____ begins _____ and will be due on the first of each successive month thereafter until departure from the program.
